Summary of Program

1. Describe how the LEA will support campus(es) in carrying out school support and improvement activities, including how the LEA will develop a web-based improvement plan for the eligible campuses selected for this grant.

LEA will support campuses in carrying out school support and improvement activities by developing an web-based improvement plan using Plan4Learning. Improvement Plan will include goals, activities, and a timeline to monitor student progress. The campus uses the needs assessment to create the improvement plan. The campus improvement committee plays a big role in creating the plan based on the findings of the needs assessment process. They will use the CNA summaries guide from the Plan4learning platform as a tool to create the needs assessment. The plan will be created based on the needs determined. The comprehensive needs assessment will drive the campus improvement plan and it is housed on the Plan4learning web-based platform.

2. Describe how the LEA will monitor schools receiving the ESF-Focused Support Grant, including how the LEA will: (a) Monitor a web-based improvement plans upon submission and during implementation, and (b) Implement additional action following unsuccessful implementation of such plan after the first year of the grant cycle.

The district will set six-week meetings with campus principals to analyze if the goals and activities are successfully being implemented. Some of the activities will include PLC Meetings where Instructional Coaches provide direct coaching to teachers. If goals and activities are identified as not being implemented successfully, an action plan to identify root causes will be developed to ensure that the activity or goal is implemented successfully. The data sources will also be reviewed. If necessary, adjustments will be made to prioritize the needs. In addition, it might require that resources are shifted in order to meet those needs. Most importantly, the LEA will continuously communicate a clear vision for continuous improvement towards student success. To ensure that everyone understands the vision, the LEA will implement campus initiatives focused on teaching and learning.

Goals, Objectives, and Strategies, Performance and Evaluation

The LEA will allow the campuses to modify bell schedules in order to provide additional support and intervention to students. For example, the campus may modify the traditional bell schedule to a block schedule for one day weekly. In addition, campuses may provide extended day tutorials in lieu of Saturday Tutorials. Principals will have the flexibility to change or adjust teaching assignments based on student achievement.

Budget Narrative

1. The proposed budget will meet the needs and goals of the program. Personnel costs (6100) will be budgeted for teachers and tutors in the subjects of ELAR and Math to supplement Tier 3 student academic attainment. The budget will also include a stipend for administrators assigned to oversee the grant and lead the work for school improvement. For object code 6200, professional development will be offered to teachers participating in Pathway 1. This will be in partnership with the ESC-2. They will provide coaching sessions and professional learning that connect to the Effective Schools Framework. For object code 6300, it will include additional technology devices for the campuses to provide access to web-based learning, web-based learning software to supplement math and reading classroom instruction, books for professional development, student materials, and other supplies to enhance student learning. Adjustments will be made in the future to meet needs by prioritizing the spending. Prioritizing the spending will allow the schools to sustain the work that has been done in order continue the practices that are proving to be effective.

The LEA will use Title I, ESF-Focused Support Grant funds to implement most aspects of supplemental student interventions. To increase program effectiveness, the district will coordinate these supplemental funds with State, Federal, and Local funds to provide appropriate programs, instruction, and services to all students.
