Introduction

In 2019, the 86th Legislature included a provision in the General Appropriations Act that required the Texas Education Agency (TEA) to gather information about the fees collected by charter schools and the number of students classified as “leavers.” The information in this report presents data on both fees and leavers during the 2020-2021 school year. The Texas Legislature mandated this collection for the first time during the 84th Legislative Session’s General Appropriations Act for the 2016-2017 Biennium (Rider 71, Page III-20). The 85th Legislative Session’s General Appropriations Act for the 2018-2019 Biennium (Rider 59, Page III-20) included identical reporting requirement language.

The legislative provision in the General Appropriations Act for the 2020-2021 Biennium, passed in 2019, requires the creation of this report. In the act, on Page III-21, Rider 58 reads as follows:

Out of funds appropriated above, the Texas Education Agency shall annually collect information from each open-enrollment charter school concerning fees collected from students by the open-enrollment charter school under the authority of Section 12.108 (b), Education Code, and information about students enrolled in an open enrollment charter school who do not complete the school year at the school. The agency shall produce and submit to the legislature by January 1 of each year a report that details the following:

- 1) the amount each open-enrollment charter school collects for each type of fee listed by Section 11.158 (a), Education Code; and*
- 2) the number of students enrolled in the charter school who do not complete the school year at the school by leaver code and by the six-week period the student exited.*

The collection of leaver data as required by the act lags by one year due to the Public Education Information Management System (PEIMS) data collection and submission timeline. Snapshot data collected in the fall of a given year represents the final leaver counts and codes from the preceding year. This data requires processing and validation; consequently, it does not become available until the following spring. To parallel the leaver data, the data collected on fees also reflect the 2020-2021 school year.

About Texas Charter Schools

Texas authored its first open-enrollment charter school legislation in the 75th Legislature under [Texas Education Code \(TEC\) Chapter 12](#). The stated purposes of charter schools are to:

- improve student learning;
- increase the choice of learning opportunities within the public school system;
- create professional opportunities that will attract new teachers to the public school system;
- establish a new form of accountability for public schools; and
- encourage different and innovative learning methods.

Texas Charter School Portfolio

Charter schools are public schools or LEAs operated by eligible entities such as 501(c)(3) non-profit organizations, governmental entities, and colleges or universities. At a minimum, charter schools will have one charter school campus associated with the charter LEA, and in many instances, there are multiple charter school campuses associated with a charter LEA. The chart below contains a summary of information for charter schools that participated in the 2022 Student Fees Survey regarding the 2020-2021 school year.

Beyond the state-authorized portfolio, 26 school districts were operating 121 campus charters authorized under TEC Chapter 12, Subchapter C. There have never been any home-rule district charter schools authorized in Texas as provided for in Subchapter B.

This report focuses on the state-authorized portfolio of open-enrollment charter schools authorized under Subchapter D, E, G and Human Resources Code.

Student Fees

About Student Fees

There are statutory provisions that regulate the fees that public schools may charge, TEC [§11.158](#) and [§12.108](#). Public schools are required to adopt a policy for waiving student fees in case of financial hardship under TEC [§11.158\(f\)](#), which states that:

“A school district shall adopt reasonable procedures for waiving a deposit or fee if a student or the student’s parent or guardian is unable to pay it. This policy shall be posted in a central location in each school facility, in the school policy manual, and the student handbook.”

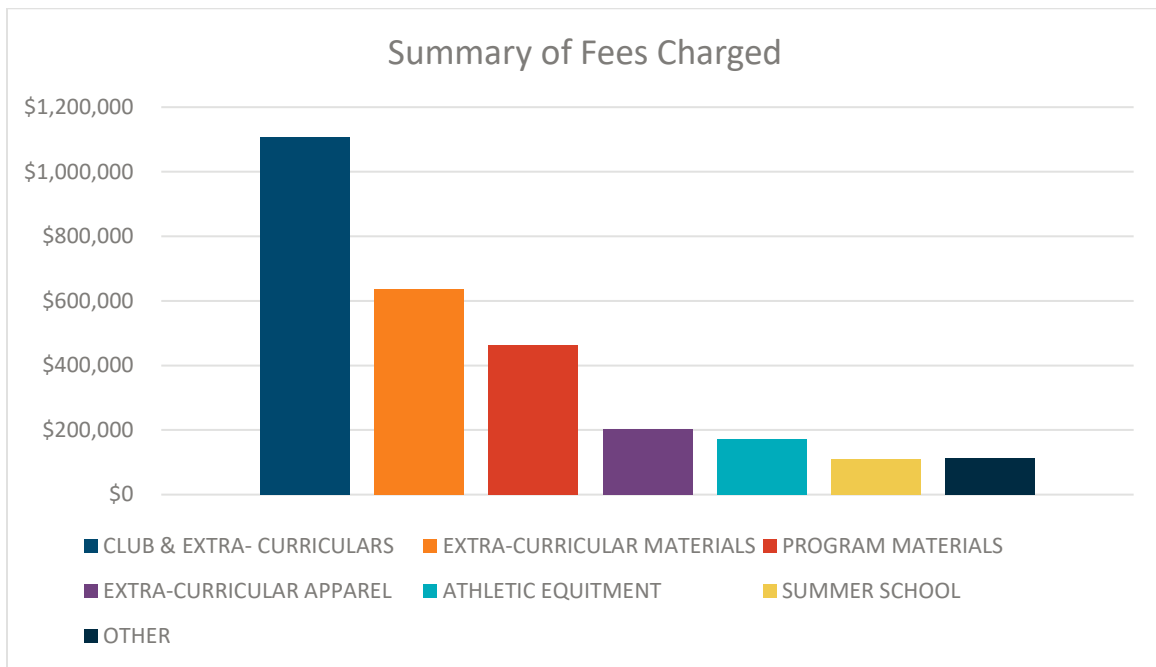
These policies are developed and approved by the charter school’s governing board.

Fee Survey

To acquire information on the fees collected by each open-enrollment charter school, the TEA required charter school superintendents to gather the requisite information. The research team for this project created and distributed an online survey to charter school superintendents, asking questions based on the provisions under TEC [§11.158\(a\)](#). All Subchapter D, E, G and Human Resources charter schools active in the school year 2020-2021 in the state-authorized portfolio received the fee survey. Two active charter schools did not complete the fees survey, and one charter school did not complete the survey due to being inactive during the collection. The data below represents responses from 179 currently active charter schools out of the 182 that were operating during the 2020-2021 school year.

Leaver Data

Overview

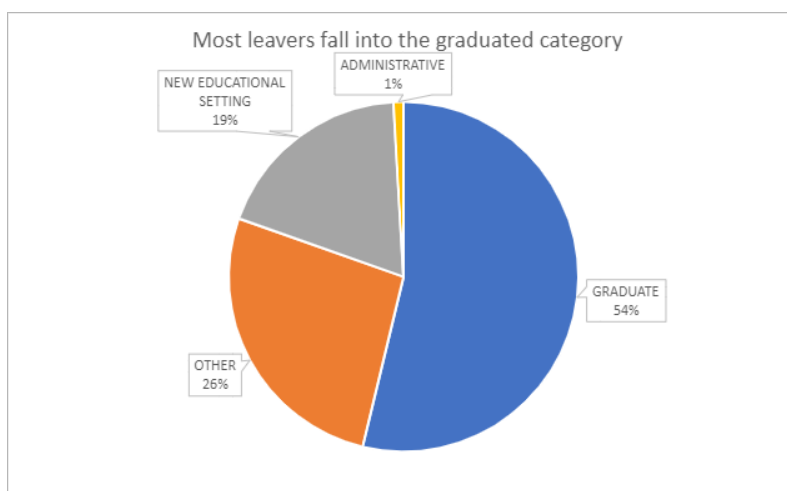
[Texas Education Data Standards](#) defines a leaver as someone who was a prior year student but not a current year student. TEA collects information when a student transitions from one educational environment to another, or when the student leaves the educational setting altogether. This ensures proper allocation of resources and provides information regarding a student's exit from the public school system.

Leaver data is collected for students in grades 6 to 12, through the Texas Student Data System (TSDS) Public Education Information Management System (PEIMS), and validated in the fall per the annual [Leaver Data Records Data Validation Manual](#). Four main leaver categories are used:

1. Graduated: These codes denote students who left a school due to their education ending and the student receiving a high school diploma or a Certificate of High School Equivalency, such as a general education diploma.
2. Moved to Another Educational Setting: The student moved from one school to receive education in another setting (i.e., transitioning to homeschooling or private school).
3. Withdrawn by District: The student no longer attends the school due to expulsion, ineligibility for enrollment, or Child Protective Services requirement.
4. Other: Any other reasons for leaving the school.

Leaver Data

The graphic below illustrates how charter school student leavers are disaggregated by leaver category. Of the total reported student leavers, the majority are coded as 'graduated'.



The table below displays the number of students enrolled in charter schools by school year (as reported by PEIMS), as well as the number of charter school leavers in grades 6 through 12 (as reported by TSDS).

Appendix

Data Variances in Fee Survey

As discussed earlier, despite all efforts to create a rigorous survey and collect the most accurate data possible, there are always potential discrepancies, especially when looking at data from year to year. Some inconsistencies in the data may be related to responder differences from year to year. Although the methodology and questions were like those previously used, the schools may have assigned different individuals to respond to each survey from year to year, leading to varying interpretations of their fee structures and which categories in which they fall. The TEA continues to improve methodologies and will develop additional guidance to achieve more accurate results on future surveys.

Data Variances in Leaver Data

Minor inconsistencies in the leaver data may arise from the timing of the data collections. The attendance data that was used is based on a “snapshot” of the school’s enrollment taken on the last Friday in October of the school year; leaver data is submitted in the fall of each year but is based on all students who left during the previous year, meaning that some students may have embarked before the snapshot being taken. Similarly, students may have enrolled after the snapshot was taken, and then left again in the following year. Also, leaver data does not account for students advancing into a grade no longer served by the charter school or charter campus.
