TEA Program Requirements

1. **Identification of Needs**: Describe your plan for identifying dual credit faculty needs for this grant, as well as in the future. What systems will you put in place to ensure each CCRSM cohort is offered a sequence of coursework which will lead to a postsecondary credential?

As an ECHS turned P-TECH campus since 2016, Beaumont ECHS is all too aware of faculty needs on the campus. One of the early challenges that the campus is still working to overcome is the delivery of dual credit course work in an online format when an instructor cannot be hired by the ISD or utilized by the IHE. The only workable solution that has been found in the past is for the IHE to utilize an online instructor for courses that do not have a local instructor that can report to either the IHE or ISD campus for classes. Gaining access to these grant funds will help to supplement that effort by providing dual credit staff hired by the ISD for on campus, traditional face-to-face teaching. If COVID has taught educators anything, though online coursework is available and teachers have done tremendous work ensuring all students are able to access their classes, online learning is an insurmountable challenge for many students in Kindergarten through 12th grade. No amount of technology is an adequate substitute for face-to-face teaching, especially when considering foundational skills that are being taught for future educational and workforce success. The current sequence of coursework outlined in our crosswalks and the additional staff that can be supplemented by this grant opportunity will help to ensure that all of our students have access to an instructor on campus, thereby providing students with daily access for extra support and assistance. Though we have six pathways for students to choose from, the courses applied for in this grant are on all six pathways and would touch every student. For that reason, the crosswalk for the Associate of Arts in General Studies is included in this grant application. The coursework will lead to one of seven possible outcomes on our campus:

Masters Degree in Curriculum and Instruction - Sam Houston State University

BECHS staff met with Dr. Kathleen Rice, Associate Dean of Graduate Studies, and Dr. Sandra Stewart, Associate Dean of Teacher Education. A letter of assurance was sent from Dr. Stacey Edmonson, Dean of the College of Education. The College of Education at Sam Houston State University (SHSU) is committed to working in collaboration with Beaumont Independent School District (BISD) for dual credit education opportunities. SHSU is committed to providing the needed coursework to educators in Beaumont ISD achieving a Master of Education in Curriculum and Instruction and commits to offering the coursework that will enable the educators to complete their degree by June 2023.

Masters Degree in Art - Stephen F. Austin University

Stephen F. Austin State University, School of Art, has pledged to collaborate in the expansion of dual credit education opportunities with the qualifying Beaumont Independent School District (BISD) educator. As a result of Beaumont Early College High School 's correspondence with William Nieberding, Stephen F. Austin 's Associate Professor of Art and coordinator overseeing the Master of Arts in Art Education Program (MAAE), he has structured a degree program for the working teacher with thirty credit hours which can be completed in two years. The coursework will be complete by the end of June 2023. The School of Art faculty are committed to providing graduate level coursework for those enrolled in the MAAE program through in-person and remote delivery of instruction. Masters Degree in English - Stephen F. Austin University

The Department of English and Creative Writing at Stephen F. Austin University will provide graduate level instruction to participating educators. Beaumont Independent School District is coordinating with Stephen F. Austin University to provide an accelerated credentialing program that will expand dual credit faculty at Beaumont Early College High School. BECHS staff met with Dr. Elizabeth Tasker Davis, Coordinator of Graduate Studies at Stephen F. Austin University, to discuss an accelerated credentialing program. Ms. Davis indicated that the existing Master of Arts in English Literature program satisfies the accelerated criteria--multiple classes are offered every fall, spring, and summer. Educators can complete the 36 hour program by June of 2023.

What commitment has the applicant made to educators to ensure that they will be able to teach college courses upon satisfaction of meeting credentialing requirements? What commitment has the applicant asked of educators to ensure that they will continue to serve the CCRSM beyond the grant period to teach college-level courses?

Beaumont ECHS identified three current staff members utilizing a short survey to determine if current staff would be interested in pursuing a master's degree to teach in the identified areas of need. The identified staff were then engaged in a very hands-on effort to prepare all supporting documentation for this grant application. In order to support their completion of the accelerated credentialing program, Beaumont ECHS will take steps including, but not limited to, the following:

Staff will be provided professional development days upon request and by mutual agreement in order to take time away from work to address pressing needs of the program without using their personal leave time.

Upon request, time will be provided during the workday and classes can be covered in order to attend daytime Zoom meetings with university professors, officials, etc.

In the event staff have program specifications that include surveys, research, etc. for which information from students is needed, Beaumont ECHS will work with the staff member, students, and parents to make this information or activity possible.

Educators are prepared to, and will be asked to, sign a local assurance to remain in the district and teach at Beaumont ECHS for a minimum of an additional three years after completion of the masters degree program. As lifelong residents of the Beaumont area, the educators participating in this grant application are likely to be at Beaumont ECHS long after that three year minimum.

Budget Narrative

Describe the disbursement plan for the expenses incurred by educators participating in the program. Describe anticipated risks for this project and the adjustments which may be made over the course of the grant period.

The budget, as proposed, will support the needs and goals of the Beaumont ECHS program by providing much needed face to face staff for a population of predominantly at-risk and economically disadvantaged students (approximately 70%). Staffing during the last two years of operation has relied heavily on instructors provided by the IHE that are offering online classes in many of our core areas and most of our program-specific areas. It has been difficult for students to communicate with their instructors and almost impossible to build relationships that foster the transmission of soft skills that so many students lack today. The areas that are requested in this grant application are those that every student in the program takes classes in. The staff applying for this grant are all phenomenal educators that are some of our most skilled in identifying student needs and working to meet those needs and close skill gaps. The budget will also cover the needs of the program in terms of instructional expenses, supplies, materials, and travel. Tuition and fees will be covered by the grant fund and the teacher applicants have also calculated textbooks to be included. For the Master's in Art, that teacher has calculated the travel cost associated with the residency requirement as well as the cost of art supplies and the exhibition set out as a program requirement. Each of the three teachers will have travel costs that incorporate one trip to the university campus each semester to meet with the appropriate university-level program staff. There is no projection for additional staff, non-employee costs, capital expenses, etc. The focus for this grant is reimbursement of expenses incurred by the educators.

Beaumont ECHS does not currently have any matches that are anticipated, but in the event one is arranged, an amendment will be filed.

Per TEA program guidelines for this grant, funds will be dispersed at the end of each semester, including summer and mini sessions, after the educator has provided a copy of the most recent transcript and receipts detailing expenses that were incurred by educators participating in the program. In the review of the transcript, course completion with a 75 or higher will be verified.

There are no anticipated risks associated with this grant opportunity, but there may be an amendment associated with the funding amount of the Master's in Art through SFA University. That program has a four-week residency requirement during the summer and, though costs were estimated based on information received from the program chair at SFA, it would not be surprising to find that the amount needs to be adjusted due to that residency requirement, art supplies that will not be known about until coursework begins, and materials associated with the required art exhibition. In the letter of assurance from SFA the program director noted that they will work with our educator regarding these requirements and at the time of the grant Beaumont ECHS is not certain what the final expense will be.
