Needs Assessment Overview

Needs Assessment for Title I, Part C

- Texas MEP has identified 8 statewide needs.
- MEP services must be based on identified needs.
- Various NCLB programs require comprehensive needs assessment (CNA).
- MEP needs assessment must be incorporated into CNA for Title I, Part A.

Statewide Needs

Early Childhood/Primary:

1. More migrant first graders must be promoted to second grade.

<u>Grades 3-11:</u>

2. More migrant students who failed the TAKS in any content area must attend summer TAKS remediation.

Statewide Needs (continued)

- Middle School: More migrant middle school students must...
- 3. Use effective learning and study skills.
- 4. Have timely attention and appropriate interventions...
- 5. Have necessary homework assistance and tools at home.

Statewide Needs (continued)

Secondary Students:

- More migrant secondary students must earn required credits for on-time graduation.
- 7. More migrant secondary students must make up coursework missing due to late entry and/or early withdrawal.

Statewide Needs (continued)


Students Migrating Out of State in Summer:

8. More students migrating outside of Texas in summer must be served in out-of-state summer migrant programs through interstate coordination efforts.

Access to Data

- A must for needs assessment;
- Requires coordination among data management and program staff.

General Four-Step Process

For EACH STATEWIDE NEED

Step 1: Review statewide need.

Step 2: Gather and analyze data.

Step 3: Determine who and how to target students to be served.

Step 4: Determine services to be delivered.

<u>Statewide Need 1:</u> More migrant first graders must be promoted to second grade.

Using the LNA Tool for Statewide Needs

- Tool is in MS Excel format.
- Each tab at bottom of screen accesses different worksheet tailored to specific statewide needs.
- Tool can be simplified, enhanced, or customized to suit user's expertise or preference.

From Needs Assessment to Service Delivery

Putting LNA Findings to Proper Use


Ensure that:

- Identified migrant students' needs are reflected in District Improvement Plan.
- LEA's NCLB Consolidated Application is completed based on services to meet identified needs.
- Data is revisited each year to evaluate whether services are effective in closing achievement gaps.

Limitations of the LNA Tool

- Designed to help LEAs select and plan MEP supplemental services based on identified needs.
- Does not reflect process for coordination with other programs and required MEP activities.

Coordination of Services: Migrant students should be served with what is available to non-migrant students.



Use of MEP vs. Other Funds to Meet Migrant Students' Needs

Migrant Needs that Cannot Be Met with Other Funds (e.g., recruiter, NGS staff, migrant services coordinator, etc.)
