#### 2. Associate Commissioner's Comments Regarding the SBEC Agenda

Ms. Cook gave a brief summary of item 11, New TExES Generalist EC-6 and Generalist 4-8 Examinations, prior to hearing public comments on the item.

#### 5. Election of Board Chairperson

#### 6. Election of Board Vice-Chairperson

Motion was made by Ms. Druesedow to nominate Ms. Christie Pogue. Second was made by Mr. Allard. No other nominations were received and the Board voted unanimously in favor of the election Ms. Poque.

#### 7. Election of Board Secretary

#### **Motion and Vote:**

Motion was made by Ms. Druesedow to nominate Ms. Kathryn Everest. Ms. Everest declined. Motion was made by Ms. Everest to nominate Ms. Suzanne McCall. Second was made by Ms. Pogue. No other nominations were received and the Board voted unanimously in favor of the election of Ms. McCall.

#### 8. Proposed Revisions to Board Operating Policies and Procedures (BOPP)

Mr. Byer noted minor changes made following the August meeting and outlined three options for the Board, related to section IV (A) (10)(c) of the BOPP, regarding who can present oral arguments to the Board.

#### **Motion and Vote:**

The Board was in agreement with all the minor changes.

Motion was made by Ms. Robison for option three - oral argument shall be presented by a single individual. Second was made by Dr. Cain. After further discussion and clarification, the motion was withdrawn by Ms. Robison.

Motion was made by Ms. Robinson for option two - oral argument shall be presented by up to two individuals authorized by the party. Presenters may be a licensed attorney representing the party, an authorized party representative or the party. Second was made by Ms. Pogue and the Board voted unanimously in favor of the motion.

### 9. Consideration of and Opportunity to Approve Additional Classes of Certificates for Educator Preparation Programs Current Rated Accredited

#### **Motion and Vote:**

Motion was made by Mr. Allard to approve Hardin-Simmons University to offer the Superintendent class of certification. Second was made by Ms. Druesedow and the Board voted unanimously in favor of the motion.

## 10. Consideration of and Opportunity to Approve a Panel of Mental Health Experts Required for Implementation of Texas Education Code, §21.044(c-1) and (c-2)

Ms. Nix presented a proposed panel that is necessary as a result of Senate Bill (SB) 460, 83rd Texas Legislature, Regular Session, 2013, which requires a panel of experts to compile information addressing the most prevalent mental or emotional disorders among children. Ms. Everest wanted to know the credentials of the panel members. Ms. McCall requested more West Texas and smaller districts represented.

Motion was made by Dr. Buckingham to accept the panel of mental health experts, with potential additions. Second was made by Ms. Pogue and the Board voted unanimously in favor of the motion.

#### 11. Discuss New TExES Generalist EC-6 and Generalist 4-8 Examinations

Ms. Cook presented this informational item to provide the Board with an overview of the implementation of the requirements of House Bill (HB) 2012, and HB 2318, 83rd Texas Legislature, Regular Session, 2013, related to the development of new Generalist EC-6 and Generalist 4-8 certification examinations.

Dr. Buckingham formally recommended that one year be changed to two years to complete credentialing requirements for the Generalist EC-6 and Generalist 4-8 test.

Ms. Dover corrected the reference in the meeting materials to the ALJ's Recommendation – the ALJ recommendation should read "3 years suspension, to run concurrently with his term of community supervision, August 18, 2011 to August 17, 2014." Staff recommendation is 3 years suspension to begin the date the order is signed.

#### **Motion and Vote:**

Mr. Allard requested that this case be moved to closed session.

Recess at 12:33 p.m. Reconvene at 12:58 p.m.

Motion was made by Mr. Allard to accept the Proposal for Decision and issue a final order consistent with the ALJ's recommendation of 3 years suspension concurrent with the terms of community supervision. Second was made by Ms. Everest and the Board voted unanimously in favor of the motion.

Staff recommendation: Issue Amended Final Order

Ms. Dover appeared on behalf of TEA.

Ms. Edwards, attorney, appeared on behalf of Ms. Anderson.

TEA legal filed a Motion for Rehearing because staff believed there were certain items in the order that needed to be clarified to consistent with state statute. The motion for rehearing was granted on September 18, 2013. The respondents did not file a response to the Motion for Rehearing. Some days before the SBEC meeting and scheduled rehearing, Mr. Fallon and Mr. Watts, Ms. Anderson's counsel, filed a Motion to Continue stating both attorneys had scheduling conflicts and could not appear at the October 25, 2013 meeting. TEA legal filed a response in opposition to the Motion to Continue.

Mr. Fallon and Mr. Watts asked Ms. Edwards to appear on Ms. Anderson's behalf requesting the Motion to Continue in their absence. Counsel for Ms. Anderson stated they did not receive notice that the rehearing was scheduled for October 25, 2013 until they saw it posted on the SBEC agenda. There is question as to whether the Final Order accurately reflects the decision made by this Board.

Ms. Juarez confirmed that Ms. Anderson's counsel did not receive proper notice of the rehearing.

The intent of the rehearing was to clarify the language in the Board's order. Although the order states that the 30 hours of continuing education Ms. Anderson completes must be noted on the face of her certificate, the order does not cite the SBEC rule that requires any restriction on an educator's certificate to appear on the educator's virtual certificate. There was no reprimand by the Board, but the order did state that the 30 hours of continuing education must appear on the certificate.

What is before the Board today is whether or not to grant the continuance requested by Ms. Anderson's attorneys. If a continuance is granted, the rehearing to clarify the final order will be heard at the February meeting. If the continuance is not granted, the rehearing will take place right now.

#### **Motion and Vote:**

Motion was made by Ms. Robison to grant a continuance on this case. Second was made by Mr. Allard and the Board voted in favor of the motion, with Dr. Buckingham abstaining.
