<u>MOTION AND VOTE</u>: It was moved by Ms. Pérez and seconded by Mr. Cortez that the State Board of Education schedule a special meeting prior to December 15, 2017 to consider action on proposed revisions to 19 TAC Chapter 231, <u>Requirements for Public</u>

<u>School Personnel Assignments</u>, Subchapter C, <u>Grades 6-8 Assignments</u>, and Subchapter E, Grades 9-12 Assignments. The motion failed.

Under Texas law, two-thirds of the SBOE members present and voting must vote to reject the proposed SBEC rule or it takes effect. Although a majority of board members voted to reject the rule, the SBOE did not reach the two-thirds threshold, and the SBEC rule will take effect.
