The charter school is taking the following steps to address the areas of identified deficiency. 

INCLUDE A DESCRIPTION OF CURRENT INFORMATION PERTINENT TO THE CHARTER SCHOOL'S IMPROVEMENT EFFORTS, ALONG WITH INFORMATION FROM ANY IMPROVEMENT PLANS CURRENTLY IN FORCE. 

Under law, if the current accreditation concerns for the charter school are not addressed, the charter school may be assigned an accreditation status of Accredited-Probation or Not Accredited-Revoked. A Not Accredited-Revoked status means that the TEA no longer recognizes the charter school as a Texas public school. Charter schools with an accreditation status below Accredited also may be subject to additional accreditation sanctions as referenced in statute and rule.

Furthermore, charter schools that fail to meet academic accountability, financial accountability, or any combination thereof for three of the preceding school years meet the default closure provisions under Texas Education Code 12.115(c) and are subject to closure.
